

PETITION FOR ANNEXATION

We, the undersigned, are the owners of a majority of the acreage legally described on Exhibit A to this Petition and within the boundaries depicted on the map attached as attached Exhibit B and a majority of the registered voters residing in such area. We hereby petition that all land described on the attached Exhibit A be annexed to and become a part of the City of _____, Washington pursuant to the Alternative Direct Petition Method of Annexation described in RCW 35A.14.420, *et seq.*

We further understand and agree that the property within the territory that we request be annexed shall be subject to the conditions imposed by the _____ City Council in its motion authorizing the circulation of this petition. A copy of the _____ City Council’s motion authorizing the circulation is attached to this petition as Exhibit C.

As petition signers, we acknowledge that the following rules apply to the signing of this petition and we certify that we have complied with all such rules in signing this petition:

1. Each signature shall be executed in ink or indelible pencil and followed by the name and address of the signer. Signatures, including the original, of any person who has signed the petition two or more times will be stricken. Signatures followed by a date which is more than six months prior to the date this petition is filed with the City of _____ will be stricken.
2. Any person signing this petition as a property owner must be the owner appearing in the records of the county auditor. Where property is owned by a married couple, only one spouse need sign the annexation petition. In the case of mortgaged property, the signature of the mortgagor (borrower) is sufficient, i.e., the mortgagee (lender) need not sign. In the case of property purchased on a real estate contract, the signature of the contract purchaser is sufficient as long as the contract has been recorded in the records of the county auditor.
3. An officer of a corporation owning land within the area involved who is duly authorized to execute deeds or encumbrances on behalf of the corporation may sign the petition on behalf of the corporation. A certified excerpt from the bylaws of the corporation showing the authority to sign must be attached to this petition.
4. When property stands in the name of a deceased person or any person for whom a guardian has been appointed, the executor, administrator, or guardian, as the case may be, may sign this petition.
5. When a parcel of property is owned by multiple owners, the signature of an owner designated by the multiple owners is sufficient.
